Notice for Engagement of Clinical Psychologists on contractual basis.

The Centralised Committee constituted by the Health & Family Welfare Department, Govt of NCT of Delhi will conduct Walk-in-Interviews for engagement of Clinical Psychologists (Teaching and Non-Teaching) on contractual basis in different Hospitals/Medical Institutions under Govt of NCT of Delhi. There will be a common interview for these two non-medical posts. The candidates will be selected for either of the two posts taking into consideration their eligibility, performance in interview, preference of post and other relevant parameters.

The Walk-in-Interviews will be held at Maulana Azad Medical College (MAMC), 2, Bahadur Shah Zafar Marg, New Delhi-110002.

The following is the Detailed Information:--

1) SUBMISSION OF FORM

Eligible candidates are requested to fill and submit the Google Form using the link [CLICK HERE](#) by 12th February 2026 (11:59 PM). Only those candidates who fill this Google Form by the due date will be eligible to appear for the Walk-in-Interview. The above link will be disabled after the above deadline.

2) INTERVIEW SCHEDULE

The interview will be held in the first week of March 2026. The schedule of the interview will be uploaded on the website of MAMC after 12th February 2026.

4) EDUCATIONAL QUALIFICATION & EXPERIENCE:-

A) For Assistant Professor (Clinical Psychology in CDC, Pediatric Department):-

- i) Master's degree in Psychology or equivalent from a recognized University.
- ii) M. Phil. Or Diploma in Medical & Social Psychology or equivalent from a recognized University.
- iii) Two years teaching experience in Clinical Psychology including experience as a Clinical Psychologist in a Psychiatry Hospital, Clinic or Child Guidance Clinic.

Desirable:

- i) Doctorate Degree in Clinical Psychology or Anthropology or Social Psychology.
- ii) Experience in individual and group Psychotherapy and counseling techniques.

B) For Clinical Psychologist:-

- i) Master's Degree in Psychology.
- ii) M Phil in Medical & Social Psychology.

5) AGE LIMIT

Not exceeding 35 years as on date of Interview. (Age relaxation will be as per extant rule for candidates belonging to reserved category (SC/ST/OBC/PwD/EWS))

6) REMUNERATION

Rs.56,100/- pm plus DA only i.e. at the entry level in PB3 level-10 as per 7th Pay Commission

7) DOCUMENTS REQUIRED

- a) Duly filled Application Form (Print out of the filled google form)
- b) Copy of Certificate/Mark Sheet of Matriculation/Class X
- c) Copy of Certificate/Mark Sheet of Senior Secondary/Class XII
- d) Copy of Master's degree in Psychology or equivalent from a recognized University
- e) M. Phill. Or Diploma in medical & Social Psychology or equivalent from a recognized University
- f) Two years teaching experience in Clinical Psychology including experience as a Clinical Psychologist in a Psychiatry Hospital, Clinic or Child Guidance Clinic
- g) Copy of Caste Certificate (SC/ST/OBC/)
- h) Copy of OBC Certificate along with Non-Creamy Layer Certificate valid for financial year 2025–2026 issued by Govt. of NCT of Delhi
- i) Copy of EWS Certificate valid for financial year 2025–2026 issued by Govt. of NCT of Delhi
- j) Copy of appropriate Certificate for candidates belonging to PwD category.
- k) A Proof Identity issued by a Govt Authority like Aadhar, PAN, Passport etc.
- l) Any other document (if applicable)

8) FEE:-

A Fee of Rs. 1000/- will be charged from the UR, OBC & EWS applicants in the form of 'Demand Draft', issued in favour of "PAO-XV" payable at New Delhi (Non-refundable). The SC/ST/PwD applicants are exempted from payment of fee.

9) GENERAL TERMS AND CONDITIONS

- i. The candidate will appear for the interview on the scheduled date and venue only. No request for change of date will be entertained.
- ii. The candidates are requested to bring all original documents alongwith one set of self attested Xerox copy of their documents from class Xth onwards.
- iii. SC/ST certificates issued only from Competent Judicial/Revenue authorities shall be accepted.
- iv. OBC Category Candidates are required to submit their Caste Certificate along with Non-Creamy Layer (NCL) Certificate, issued after 31.03.2025 by Govt. of NCT of Delhi in r/o the "Community" they belong to, which is recognized as Other Backward Class under the Government of NCT of Delhi Notification no. F.28(93)/91-92/SCST/P&S/4388 dated 1995-01-20, published in the Gazette of Delhi Extraordinary Part-IV.EWS certificate valid for financial year 2025-2026 shall only be accepted.
- v. In case of EWS the engagement is provisional and is subject to the Income and Asset Certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
- vi. No TA/DA will be paid for appearing in the interview.
- vii. The appointed candidate will not be entitled to any kind of accommodation and other concessionary allowance.
- viii. Appointee/employee to the post will not be entitled to claim permanent position/regularization of services in any condition.
- ix. Agreement in the Standard Prescribed Format shall be signed and executed between the contractual appointee and the MS/MD of concerned hospital.
- x. The selected appointee on contractual basis shall submit two original sets of signed contractual agreement within seven days of the declaration of result.
- xi. Any letter of resignation submitted by the contractual employee will be treated as a letter communicating the intention of the contractual employee to terminate the contract. If a contractual employee wishes to terminate the contract by giving 30 (thirty) days notice, it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No notice is required, if service is terminated on disciplinary grounds/falsification of declared information/joining of regular incumbent.
- xii. The Tenure of contractual appointment will be for a period of one year or till a regular incumbent joins whichever is earlier. The contractual appointment will be terminated on joining of a regular incumbent at any time.

- xiii. The above posts shall be filled on regular basis through the authorized recruiting agency and the contractual employee will have no claim on regular recruitment solely because of contractual engagement served at the concerned hospital
- xiv. Contractual employees are governed only by the terms and conditions mentioned in the contract agreement and are not entitled for any other allowances, financial benefits or concessions of medical facilities, grant of LTC benefits, GPF, Pension Benefits, DGEHS, Provisions of FR/SR etc., that are applicable to only regularly appointed employees of Government of NCT of Delhi.
- xv. The timings of work/duties/responsibilities of contractual engagement would generally be same as those of regular appointed incumbents.
- xvi. Engagement/Appointment shall be subject to Medical Fitness and Verification of Certificates/documents/Police Verification.
- xvii. Any canvassing by or on behalf of the candidate or any outside influence in any form with regard to selection will lead to disqualification.
- xviii. The appointment will be terminated at any stage if any declaration/information furnished is found false or any material/fact is suppressed willfully or on any disciplinary grounds.
- xix. The decision of the Selection Board regarding selection of the candidates will be final and no representation will be entertained in this regard.
- xx. In case of any legal dispute, the jurisdiction of court will be Delhi/New Delhi only.
- xxi. The list of selected candidates will be displayed on the website of Maulana Azad Medical College.
- xxii. The selected candidates may be posted in any of the Hospital/Medical Institution in the jurisdiction of GNCTD under Health & Family Welfare Department, GNCT of Delhi.
- xxiii. While candidates have been asked to give preferences for posting in the Form, the same shall be only indicative and non-binding. It will not confer any right to posting at the place of choice. The posting of selected candidates by the Centralised Committee/Competent Authority shall be subject to administrative requirements, availability of vacancies, rank of the candidate in the selected list and ensuring fair/equitable distribution of candidates in all Hospitals/Medical Institutions. No claim or representation shall be entertained on the basis of the preference so indicated.
- xxiv. The candidate who is already in Government service should apply along with 'NOC' from the Employer.
- xxv. If any declaration given by the candidate proves to be false or found to have willfully suppressed any material fact, he/she will be liable for removal from service or any other action as may be deemed fit.
- xxvi. The number of posts are provisional and the Centralized Committee constituted by H&FW Department, Govt. of NCT of Delhi, reserves the right to increase/decrease or cancel the post(s) without assigning any reason. A 'Panel' of suitable candidates will be formed in addition to the selected candidates. The validity of the 'Panel' will be for one year from the date of issue of declaration of result.

- xxvii. The Competent Authority reserves the right to amend, modify or cancel this advertisement as a whole or any of its part without assigning any reason or giving notice, at any stage. Corrigendum if any, will be published only on the website of Maulana Azad medical College.
