- 1.Candidate should report in the MS **office, ESIC Hospital, Bhilai** Smriti Nagar, Bhilai, Durg from 09:00 AM to 10:00 AM on the stipulated date, candidates reporting after 11:00 AM will not be considered for Walk-in –Interview.
- 2.Reservation for other reserved categories will be executed as per existing Central Government Rules.
- 3.Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC Category must ensure that day are entitled to such reservation as per eligibility prescribed in the notice and as per the instruction issued by Government of India. They should also be in possession of the certificates in the prescribed format of Government of India in support of their claim. Candidates seeking reservation under EWS category, should submit their EWS certificate as per prescribed vide Government of India, Department of personnel and training OM no. 36039/1/2019-Estt. (Res.) dated 31/01/2019. - 6.The number of vacancies/category-wise vacancies may vary/likely to increase or decrease.
- 7.No TA/DA will be paid to candidates for appearing in the walk-in-interview.
- 8.Application should be submitted for each post separately.
- 9.The Medical Superintendent reserves the right to fill up all or not to fill up any vacancy. The Medical Superintendent reserves the right to alter the date or cancel the interview.

10. Full time/Part time specialist on contractual basis shall be recruited for a period of 01 year from the date of joining or till regular incumbent joins.

11. He / She must sign the contract on a Non-Judicial Stamp Paper of Rs. 500/- before joining. The original contract will be with the hospital and its copy will be with candidates. The cost of the Non-Judicial Stamp Paper will be borne by the candidates.

12. The specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.

13. Full time contractual Specialist will be entitled for the leave @04 days for each month of work on prorata basis in as Calander year.

14. Part time contractual specialist will not be entitled for any kind of leave.

15. Senior Resident 03 Year As per Central Government Rules adopted by ESIC. No encashment of accumulated leave. The Engagement of the 03 years senior resident will be purely contractual for one year tenure, extendable up to maximum 03 years subject to the requirement, satisfactory work performance report by HOD & performance of Senior resident.

16. Candidates working in Govt./ Private Hospital / Institute should produce NOC from their department at the time of Interview.

17. Applicants having completed 3 years of Senior Residency period in any hospital, are not eligible for applying under residency scheme.

18. The experience will not be issued in case SR-3 years and contractual Specialist resigns before completing 6 months of services.

19. The selected specialist/super specialist must have a professional indemnity policy which should cover the period as desired by ESIC in the bid. The policy is mean to cover professional liability falling on them because of error and omission committed by them while rendering professional service. The minimum sum assured per annum should be Rs. 30 lakhs for Anesthesiologists, Cardiac Surgeons, Neurosurgeons, Plastic Surgeon etc. (02) Rs. 20 lakhs for General Surgeons, Gynecologist, Obstetrician etc. (03) for Physicians, Radiologist, Pathologists etc. should be at least 10 lakhs.
