Mumbai Port Authority invites applications from candidates for the post of **Asstt. Port Safety & Fire Officer by direct recruitment on regular basis**. Candidates fulfilling the prescribed qualifications and experience given below may apply.

* **Equivalent** means B. Tech/B.E. (Fire Engineering) from a recognized University.

GENERAL CONDITIONS:

1. While there is no reservation, SC/ST/OBC candidates may apply, but will not be eligible for any relaxation.
2. As per Regulation 9 of MbPT Employees (RSP) Regulations, 2010, the age limit in case of existing employees of any Major Port is 55 years.
3. The SC/ST candidates called for written test/interview are eligible for Travelling Allowance as admissible on production of original bus/train ticket.
4. Selection will be through a competitive written examination and/or personal interview.
5. Selected candidate will have to undergo medical examination at the MbPA hospital for fitness.

6. Mere fulfilling the minimum prescribed qualifications will not vest any right upon the candidate for being called for written test/interview. Similarly, mere submission of application does not confer any right on the candidate for being called for written test/interview. No correspondence will be entertained in this respect and interim enquiry will not be attended to.

7. Crucial date for determining eligibility is 01.02.2026 i.e. the candidate should fulfill eligibility criteria with respect to age, essential qualifications and experience as on 01.02.2026.

8. Depending upon the response, the administration reserves the right to restrict the number of candidates to be called for the written test/interview.

9. Wrong declarations/submission of false information or any other action contrary to the law shall lead to cancellation of the candidature at any stage.

10. Applicants, if selected, will not be permitted to withdraw candidature at a later date.

REMUNERATION :

Regular appointments will be on the payscale of Rs. 50000-160000 on the pay pattern linked to Industrial DA and includes cafeteria allowance at 35% of basic pay with annual increment as per stipulated Pay structure. Total emoluments will be approximately Rs.94500/- per month, plus HRA as admissible (if not residing in Mumbai Port Authority quarters).

Selected candidates will be governed by the New Contributory Pension Scheme.

Other service benefits include leave, medical aid for self and dependent family, advances for purchase of house, car etc. as per the Port Authority regulations from time to time.

- (iii) The application should be accompanied by the following:
 - (a) Self-attested copies of certificates in support of age, educational qualifications and experience.
 - (b) Self-attested copy of Caste Certificate (in case of SC/ST/OBC candidates) and Caste Validity Certificate.

- (iv) Persons in service of Government/ Public Sector Undertaking / Semi-Govt. Organisations/ Autonomous Bodies must apply through proper channel along with vigilance clearance and certificate that no disciplinary case is pending or contemplated against them and No Objection Certificate for release in case of selection.
- (v) Applications incomplete in any respect or received after the last date will not be entertained.
- (vi) The last date for receipt of application is **27.3.2026**.
- (vii) Canvassing in any form will be a disqualification.
