### FOR ENGAGEMENT OF RETIRED MEDICAL OFFICERS - AYURVEDA ON FULL TIME CONTRACT BASIS.

ESIC Medical College & Hospital, NIT, Faridabad proposes to engage the Retired Medical Officer - Ayurveda on Full Time contract basis for a period of one year through walk-in interview.

Based on the number of application received by 21st March, 2026 the candidates will be called for screening test (if the number of candidates will be more than 20) or direct interview & the list of candidates shortlisted for interview will be published on ESIC website (recruitment section of [www.esic.gov.in](http://www.esic.gov.in)) and the same will also be intimated to the candidates on the email as mentioned by them in the application form.

#### Important Instructions:

1. Only those candidates who are retired from Central Government/State Government (including their PSUs) will be eligible to apply for the post.
2. Only those candidates whose documents are verified and who qualifies minimum eligibility criteria (as per their application form and documents sent through email) will be called for screening test/walk-in interview.
3. The shortlisted candidates will bring the original documents along with duly filled application form on the day of screening test/walk-in interview for verification.
4. DEAN, ESIC MCH Faridabad reserves the right to vary these vacancies inducing increase or decrease or cancellation of filling up of any or all posts without assigning any reason.

5. The date & time of screening test/walk-in interview will be published in **RECRUITMENT SECTION** of the ESIC website i.e. [www.esic.gov.in](http://www.esic.gov.in)
6. The DEAN, ESIC MCH Faridabad may conduct the screening test and interview on different dates depending upon number of applications and feasibility.

### **Eligibility Criteria:**

1. Must have been retired from Central Government/State Government (including their PSUs) to apply for the post.
2. Must have a degree in Ayurveda from a recognized university or statutory state board or Council or Faculty of Indian Medicine under the Indian Medicine Central Council Act, 1970.
3. Must have enrolled in Central Register of Indian Medicine or State Register of Indian Medicine.
4. Must not have been more than 68 years of age as on 21st March, 2026.
5. Must submit Pension Payment Order (PPO) and Pension Passbook copy for verification.

### **Emoluments:**

Basic pay equivalent to Level - 10 of the 7th CPC and other allowance as applicable. The total payable amount as remuneration will be computed after deducting the amount received by concerned as Pension (basis and dearness relief).

### **General Terms & Conditions:**

1. The above engagement will be purely on contract basis and shall be valid for a period of one year and it will be extendable on yearly basis subject to appointment of regular incumbent, satisfactory performance, attainment of age of 70 years, etc.
2. The contractual engagement may be terminated/discontinued from either side by giving one month prior notice. However, in case of any misconduct, negligence or non performance the services of contractual medical officer may be terminated at any time by DEAN, ESIC MCH Faridabad without serving any notice period.
3. The contractual medical officer will be entitled to 2.5 Leaves for per completed month of the service. Accumulation of leaves beyond a year will not be permitted.
4. The contractual medical officers are required to mark attendance manually as well as on AEBAS (Aadhar Enabled Biometric Attendance System).
5. Since the engagement is being full time in nature, the contractual medical officer would not be permitted to take up any other assignment during the period of contract and private practice of any kind will not be permitted.
6. The appointment of contractual medical officer will be subject to Medical Fitness at the time of joining.

7. No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance, Medical Benefits, Seniority, promotion, etc will be admissible.
8. The contractual medical officer shall work under the direct control of Medical Superintendent/Dean, ESIC MCH Faridabad.
9. No TA/DA will be admissible to appear for the screening test/walk-in interview or joining.
- 10.If the contractual medical officer at any time is unable to address the assigned work and found guilty of any gross misconduct or negligence of his/her duties, then he/she may be terminated without any notice period or payment in lieu of the notice period.
- 11.Selected candidates will have to join duty on or before the date indicated in the offer of appointment.
- 12.The contractual Medical Officer (Ayurveda) is required to submit an agreement regarding the terms and conditions of appointment on a stamp paper of Rs. 100/-.
- 13.The selection will be on the based on performance by candidate in the walk-in interview & screening test (if conducted) will be just a stage to filter the top meritorious candidates for walk-in interview. Candidates filtered for interview will be only give times the number of vacancies, in case screening test is to be conducted due to receipt of more than 20 applications.

5. Self attested copy of certificate related to category (SC/ST/OBC/PwD, etc) as per Government of India guidelines.
6. The candidate shall also produce original of the above mentioned documents at the time of screening test/walk-in interview for verification.
