Note:

- (i) These vacancies are provisional and may increase or decrease as per the actual requirement for the teaching & patient care. The competent authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving prior notice.
- (ii) Reservation will be as per Government of India guidelines issued from time to time.
- (iii) As per EWS guidelines posts are not carried forward, hence; in case of non- availability of EWS candidate; other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as an UR candidates & the selection will be only on merit basis.
- (iv) In case of non-availability of reserved category candidates in the advertised post, the vacancy may be filled up for less than 45 Days as de-reserved seats(s).
- (v) All Candidates must have up-dated Medical (NMC/ State Medical Council) with all post MBBS/ MD/ MS/ DM/ Mch/ Dr. DNB Qualification(s). In case, candidate(s) do not have up-dated registration from Medical Council, they have to show "**Applied for document(s)**" to concerned authority at the time of interview. In case, these two clauses are not fulfilled, the candidate either may not be interviewed or their results will remain with-held in case the expert committee allows them to appear at the interview. Even after that, if, candidate selected, they must have to submit updated Medical Registration Certificate on the time of reporting to join.
- (vi) Candidates working in Govt./ Autonomous/ Statutory Institution should preferably have "NOC" at the time of Interview from their Employer. In case of immediate non- availability of the same, copy of "applied for NOC" to be submitted at the time of Interview.

Eligibility Criteria

1. **Age Limit as on 24.03.2026:** 69 Years (Not Exceeding)

Note:

- (i) The maximum tenure of such engagement will be till 70 years of age for teaching faculty whichever is earlier provided other rules & regulations are satisfied.
- (ii) The EWS candidates should submit EWS Certificate (not issued prior to 01 Year from the date of interview) as per Annexure- I of Govt. of India, Ministry of Personnel, Public Grievances & Pensions, DOPT Office Memorandum No. 36039/1/2019-Estt (Res), dated 31.01.2019.
- (iii) The OBC (Non-Creamy Layer) Certificate should be issued and not prior to 01 (One) Year from the date of interview. It has to be as per the format applicable for job in Govt. of India and to be issued by an Officer not below the rank of Sub-Divisional Officer (अनुमंडल पदाधिकारी) or Equivalent Authority of the concerned State for Central Govt. job.

(iv) Reservation for PH (Divyangjan) Candidate will be maintained as per Gol norms.

2. Educational Qualifications: As per NMC (MCI) TEQ Rules as amended.

3. Pay and Allowances: Fixed Basic- ₹ 1,18,500/- & other allowance. Tax and other deductions will be as per prevailing norms.

4. Terms of Contract:

- (i) The tenure of all above post(s) will be for 01 (One) year OR attainment of 70 years of age; whichever is earlier from the date of joining with provision of yearly extension up to another 02 (Two) years on same terms & conditions and pay on satisfactory performance, willingness and conduct of candidate and requirement of this Institution. Selected candidate has to submit application for extension every year.
- (ii) This, being a contractual appointment, absence from work for a period beyond the 07 (Seven) days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The teaching faculty is required to mark attendance manually as well as on Aadhaar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days. Monthly Pay will be paid as per AEBAS attendance marked by the person concerned for his/ her working hours.
- (iii) The contractual engagement may be terminated/ discontinued from either side giving one-month prior notice to this effect without assigning reason. In case of spot resignation by the selected candidate, one month's salary is to be deposited to ESIC Account through Challan.
- (iv) No private practice is allowed in any capacity after joining as teaching faculty at ESIC Medical College, Bihta, Patna.
- (v) No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance/ Benefits, Seniority, Promotion etc. will be admissible.
- (vi) Acquired/ Accumulated Leave for 2.5 (Two and a Half) days may be availed for each completed month of work with pre approval of the Competent Authority.
- (vii) The selected candidate must have a Professional Indemnity Policy of Rs. 30,00,000/- (Thirty Lakhs) only which should cover the period as desired by ESIC. The policy is meant to cover the profession liability falling on them as a result of errors and omissions committed by them while rendering professional services.
- (viii) Other terms and condition will be applicable as issued by Competent Authority from time to time.
