## 8. CENTRES OF EXAMINATION :

8.1	Examinations / Tests are tentatively scheduled to be conducted in specified cities viz., Hyderabad, Telangana; Mumbai, Maharashtra; Rawatbhata, Rajasthan; and Pazhayakayal, Tamil Nadu. These examination centers are only indicative and not final. Though efforts will be made to conduct examination in the above specified cities, candidates may be required to appear for examination / Tests at a place other than the above mentioned places.
8.2	Candidates may indicate their choice of city (nearer to their present address) in their application form in the order of preference. Allocation of centers will be decided based on the number of candidates registering for each city. However, NFC reserves the right to add or delete centre(s) without assigning any reason.  <b>Note:</b> Schedule for Screening Test (if required), Personal Interview, Skill Test will be notified on NFC website <a href="https://www.nfc.gov.in">https://www.nfc.gov.in</a> . ## 9. ADMISSION TO EXAMINATION / INTERVIEW :

13.2	<b>PwBD candidates with OL and HH disability can submit application for the Post code 12602 and candidates with OA, OL, HH disability can submit application for the post code 12605, which are identified suitable for PwBD.</b>


