### NOTIFICATION

Sub: Filling up of the post of Chief Transport Inspector (Ex-cadre) in Level-7 of RS (RP) Rules 2016.

It is proposed to form a panel of one (01) candidate for the post of Chief Transport Inspector (Ex-cadre) in Level-7 of RS (RP) Rules 2016 from amongst suitable Group C volunteers of all depts, who are working in Level-6 of RS (RP) Rules 2016 and who have put in a minimum of two years of service in that grade, subject to continuation of the post beyond a period of six(06) months available for operation, as per this office memorandum No.RWF/TG-30/360 Dated 05.02.2026.

Volunteers must possess the following:-

1. Must be conversant with preventive/break down maintenance required for Road Transport Vehicles.
2. Ability to supervise a sizeable work force of drivers for regulating transport arrangements and control movement of these vehicles.
3. Conversant with Motor Vehicle Act, 1989, formalities in RTO's office and ability to handle documents relating to the same.
4. Ability to drive a Motor Cycle/Scooter as well as a Light Motor Vehicle and possess valid Driving License for the same.

The examination in connection with the above selection will be held through **Computer Based Test (CBT)** mode (Computer/Tablet) through an Exam conducting Agency (ECA) as per the instructions contained in Railway Board's letter No. 2025/E(RRB)/25/14 Dated 21.08.2025.

The date of examination through CBT mode (Computer/Tablet) is scheduled to be held on **07.04.2026 (Tuesday) at 10.00 hr in TTC/RWF/YNK.**

The duties attached to the above post and the syllabus for the written test are elucidated as Annexure.

The tenure of the incumbent selected is normally for a period of 04 (Four) years which can be extended for a further period of one more year, with the approval of the competent authority. However, the incumbent selected for this post, can be repatriated back to the parent cadre at any time before completion of the normal tenure, at the discretion of the administration.

In order to ensure that the staff selected for ex-cadre posts do not lose touch with the working of their parent post/cadre, a reasonable tenure say not exceeding five years is only prescribed.

The willing and eligible volunteers who satisfy/abide by the above conditions have to submit their application in the prescribed proforma **ONLINE through LAN** on or before **25.03.2026 (Wednesday)** for which provision has been made under forms in LAN.

After filling up of the application, the candidates are required to take printout of the same and submit their applications duly affixing their signatures to their respective Controlling Officer/s. The Controlling Officer/s are required to forward all such applications of all these volunteering candidates in one bunch so as to reach Personnel Department by **25.03.2026(Wednesday)**

It is reiterated that **25.03.2026(Wednesday)** is the last date for receipt of applications. In case of any failure either by the candidate or by the controlling officer to submit/forward the application forms of the candidates to Personnel department by the last date (ie) **25.03.2026(Wednesday)**, as per the procedure stated above, applications of such candidates will not be considered in the Personnel department under any circumstances.

Candidates have the option to answer in Hindi or in English in the written examination (CBT). In case, the candidates are willing to answer in Hindi, this office may please be advised in advance, but not later than **25.03.2026(Wednesday)**.

This may please be given wide publicity from amongst all the eligible staff and arrangements may also please be made to notify the staff who are on long leave, placed on sick list, proceeded on duty, training, etc. on the above subject. The responsibility of notifying the candidates rests with the Controlling Officers/Supervisors, under advice to this office.


This may please be treated as alert notice and volunteering staff should be ready to appear for the CBT examination (Computer/Tablet) as and when intimation is given by this office.

**Syllabus for the written test for the post of Chief Transport Inspector (Ex-cadre) in Level-7 of RS (RP) Rules 2016**

1. Ability to make correspondence in English/Hindi, General Arithmetic and General Knowledge.
2. Basic Technical knowledge about operation and maintenance of R.T vehicles.
3. Motor vehicle Act, traffic rules and regulations.
4. General procedure for inviting tenders/ quotations and passing bills from the suppliers.
5. Railway Service (conduct) Rules, 1966 and Railway Servants' (Discipline and Appeal Rules), 1968.
6. Official Language Policy, Integrated Management Systems.

**Duties attached to the post of Chief Transport Inspector (Transport) (Ex-cadre) in Level-6 of RS(RP) Rules 2016**

1. Maintenance of road transport vehicles of Genl.Admin and deploying drivers.
2. Checking of log book and control and ensure discipline of drivers.
3. Hiring of vehicles on regular as well as on need based by entering into contract.
4. All correspondence with Road Transport authorities with regard to registration of new vehicles of RWF and also surrendering of registration in case of condemned vehicles etc , and for proper documentation of RWF vehicles.
5. Allotment of annual fuel quota to all road Transport vehicles.
6. Arranging vehicle for GM and other CHOD/PHOD/HODs of RWF and other Railway Officers visiting RWF.
7. Obtain Entry Permit in Airport during visit of VIP/VVIPs to RWF.
8. Co-Ordinate with other higher officials of other railways , State Govt., RTO, Police dept. regarding movement of RWF/designated vehicles during MR/MoSR/CRB & Board Member visit to RWF.
9. Co-ordinate in maintaining and servicing GMs vehicle and other General Administration vehicles.
10. All other official works like putting up notings , passing bills of vehicles contracts, replying to Accounts quires etc.
11. Looking after the work of protocol Inspector/Staff and Welfare Inspector in their absence.
12. Any other work entrusted by GM/Secretary to GM/DGM.
