The Act of Parliament empowers the university to award Diploma, Degrees, and Post Graduate Degrees and PhD degrees in the field of aviation and allied disciplines. To facilitate and promote aviation studies, teaching, training, research and extension work with focus on emerging areas of studies such as aviation sciences, aviation engineering & technology, aviation management, aviation safety and security, aviation law, aviation regulation and policy, aviation medicine, search and rescue, transportation of dangerous goods, environmental studies and other related fields, etc in conjunction with the industry to achieve excellence in operations and management of all the sub-sectors within the aviation industry, the University requires faculty for its various academic units.

The University invites applications for “**Teaching Faculty (on contract)**” position for the **Autumn Semester of 2026-2027 (July 2026 to December 2026)** from energetic meritorious qualified Indian Nationals, Persons of Indian Origins (PIOs), Overseas Citizens of India (OCIs) and Foreign Nationals having passion for teaching and research possessing excellent academic background, commitment to top quality teaching and proven credentials for carrying out outstanding research and development for different courses of the University for its various academic programs in the above specializations/disciplines. Faculty members primarily dedicated to teaching and teaching related activities, such as curriculum development and enhancing teaching laboratories. These roles encompass full-time faculty members engaged through a consolidated remuneration or salary arrangement. RGNAU shall be able to provide the best possible support to the faculty members as per the regulations of the University.

Consolidated Remuneration : Rs. 75,000/- per month. No other allowances are admissible.

Eligibility Criteria:

1. At least Master degree in the relevant discipline/specializations.
2. Ph.D. qualification is not mandatory, and appointments are accompanied by consolidated salaries/honorarium.

Desirable : Ph.D. degree in the relevant disciplines/specializations.
