## **TERMS AND CONDITIONS**


1. The candidates are responsible for ascertaining and ensuring their eligibility as per the prescribed qualification and experience. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material or information, he/she will be liable for removal from service and such other action as the Government/ ICMR may deem necessary. Even after qualifying in the selection process, the candidate may be disqualified during document verification if he/she does not fulfill essential eligibility criteria.
2. Tenure: The assignments are purely on a contract basis for a period of 6 months (which can be extended to a maximum of 3 years). These Appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Kalyani/ICMR, or continued contractual appointment.
3. Expiry of Contract: The contract will automatically expire on completion of the stipulated time or earlier in case of withdrawal of support by the funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. Leave: The leave entitlement of the appointee shall be governed by the ICMR leave policy as amended from time to time.
5. Accommodation: The institute will provide no hostel or other accommodation.
6. Canvassing of any kind will lead to disqualification.
7. The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
8. Applications incomplete in any aspect will be summarily rejected, and no intimations/requests will be made to the candidate. Candidates who will be called for the final interview will be based on the complete discretion of the Screening Committee, and no intimations will be given/sent to the candidate in this regard.
9. The decision of the Selection Committee at AIIMS Kalyani regarding the selection of candidates will be final, and no representation in any manner will be entertained in this regard.
10. The appointment is full-time, and private practice of any type is prohibited.
11. He/she is expected to conform to the rules of conduct and discipline applicable to the institute employees.
12. The competent authority's decision regarding the candidate selection will be final, and no representation will be entertained.
13. The competent authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without giving any reason or notice.
14. The interview will be held at AIIMS Kalyani. No TA/DA will be paid for attending the same.
