#### 6. Maximum Age-limit: -

**Senior Resident:-** Not exceeding 45 (Forty-Five) years as on the date of publishing this notification in Institute website.

- (i) Upper age limit shall be determined as on the date of publishing this notification in Institute website.
- (ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.

7. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/OH/EWS will be considered
