Whereas, in view of the large number of applications received for the aforementioned posts of Junior Assistant, advertised vide High Court Advertisement Notice No. 02 of 2025/RR/RC dated 26.05.2025, and in order to maintain uniformity in the examination, it is hereby notified for the information of all the concerned candidates, that the examination for the post of Junior Assistant, shall now be held through **Offline OMR Mode** instead of **Online Computer Based Test (CBT)**.
