- The examination centre allotted to the candidate shall be mentioned in the e-Admit Card.
- The e-Admit Card will be available for download from 9th May, 2026 onwards. Candidates who do not possess the e-Admit Card will not be permitted to appear in the examination.
- All candidates are informed that Gates at the Examination venues will close exactly **10 (Ten) Minutes** before the scheduled commencement of Examination. They are therefore, advised to factor in unforeseen circumstances like traffic jams, weather, vehicle breakdown, parking space etc. while reaching the Examination venue. 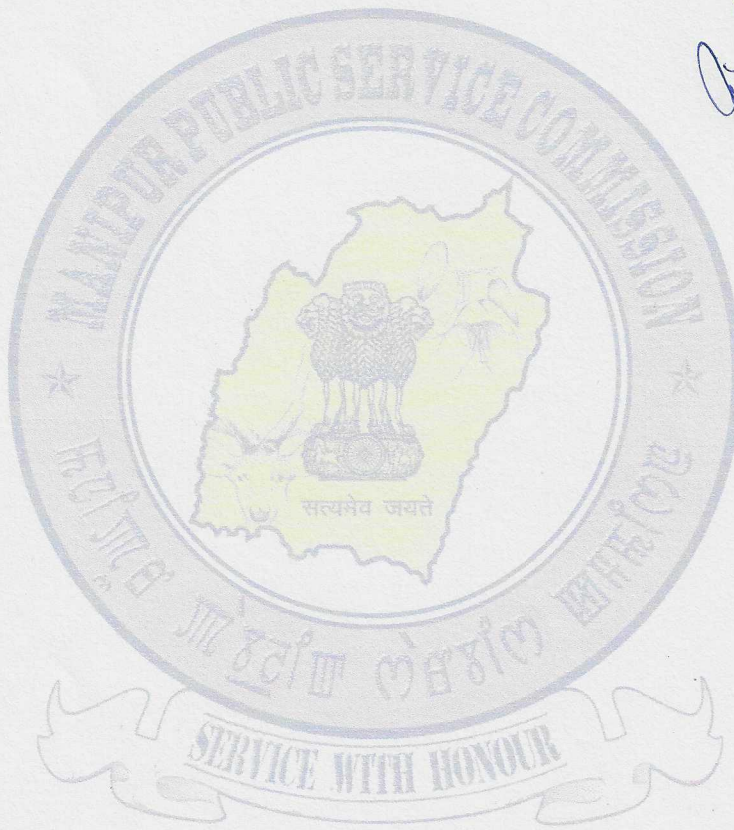
