- Valid Caste Certificate/OBC Non-Creamy Layer Certificate/Income and Assets Certificate (EWS)/Non-remarriage Certificate (in case of Widows) issued by a Revenue Officer not below the Rank of Tahsildar, as applicable.
- Disability Certificate (percentage of disability 40% or more) issued by a Competent Medical Board, for PwBD candidates, if applicable as per recruitment notification.
- Ex-Servicemen Service Certificate, if applicable.
- No Objection Certificate (NOC) from the present employer, if employed in Govt./Semi Govt./Autonomous Bodies etc.
