### **ESSENTIAL QUALIFICATIONS:**

1. Ph.D. degree.
2. Professor/Associate Professor with a total service/experience of at least fifteen years of teaching/research/administration in Universities/Colleges and other institutions of higher education.
3. A minimum of 10 research publications in peer-reviewed or UGC-listed journals.
4. A minimum of 110 Research Score as per Appendix II, Table 2 of UGC Regulations, 18 July, 2018.

### **TENURE:**

1. A College Principal shall be appointed for a period of five years, extendable for another term of five years on the basis of performance assessment by a Committee appointed by the University, constituted as per these regulations.
2. After the completion of her term as Principal, the incumbent shall join back her parent organization with the designation as Professor and in the grade of the Professor.

## General Instructions to the candidates for the above post

1. Please write Name of the Post Applied for, your name and full postal address on the back of the Demand Draft without fail.
2. No TA/DA shall be paid to the candidates for attending the interview.
3. Application fees once paid shall not be refunded under any circumstances.
4. Application will be summarily rejected if, received after the last date/incomplete in any respect/not accompanied by the full prescribed fee or sent through other than Demand Draft.
5. No fresh paper/enclosures will be permitted after closing date.
6. For any postal delay in the receipt of application form, the college is not responsible.
7. Applications not on original prescribed format will not be accepted.
8. Certificate in support of experience should be in proper format i.e. it should be on the organization's letter head, bearing the date of issue with specific period of work (with DD-MM-YY), name and designation of the issuing authority along with her signature.
9. Applicants who are in employment should route their applications *through proper channel* or should submit a 'No Objection Certificate' from the employer prior to the interview, failing which they may not be considered further.
10. Mere eligibility will not entitle any candidate to be called for interview. More stringent criteria may be applied for short listing the candidates to be called for interview.
11. Filling of all columns in the application form is required.
12. The relaxation of marks for the SC/ST/Specially-abled (Physically and Visually specially-abled) categories will be as per UGC Regulations, 18 July, 2018 and their subsequent amendments for the position.
13. The eligibility of an application shall be determined in accordance with the UGC Regulations, 18 July, 2018 and their subsequent amendments for the position.
